Sir,

I am directed to convey the sanction of the President of India to the revalidation of unspent balance of **Rs. 143.19 lakhs of 2015-16 under Additional Area Coverage of Pulses** as reported by the State Govt. of Haryana available with the State for utilization in the current financial year i.e. 2016-17.

2. This is subject to the condition that the revalidated amount be treated as part of Central Share against the Action Plan under NFSM-Additional Area Coverage of Pulses for the current financial year i.e. 2016-17. Hence, the State will be required to contribute its matching share for activities of 2016-17 as per existing sharing pattern of 60:40 between Centre and the State for implementation of NFSM-Additional Area Coverage of Pulses during 2016-17.

3. Further release of funds to the State Govt. under the programme shall be considered once, the State furnishes the utilization of unspent balance of Rs. 143.19 lakh (Central Share) of 2015-16 during 2016-17.
