
Subject: Implementation of Crop Diversification in Original Green Revolution States under RKVY programme during 2015-16 – Approval of Revised Action Plan - regarding.

In continuation of this Department's letter of even number dated 08.06.2015 and reference to letter No. 625/TA (CDP/RKVY) dated 01.10.2015 from Department of Agriculture, Government of Haryana forwarding therewith revised Annual Action Plan of Crop Diversification Programme in Haryana for the year 2015-16 for an amount of Rs. 9950.02 lakh, I am directed to convey the approval of competent authority for Action Plan of Rs.9950.00 lakh on 50:50 sharing basis between Government of India and State Government of Haryana during 2015-16 subject to the approval of State SLSC of RKVY under following conditions:


1. Rate of assistance for various interventions under cluster demonstrations is restricted as per the NFSM guidelines.
2. Pattern of assistance and ceiling amount of farm machineries, implements are brought at par with the approved rate under SMAM/NFSM.
3. Site specific activities i.e. underground pipeline (UGPL) and distribution of Dhaincha seed to promote green manuring are approved subject to approved cost norms of existing State Plan /CSS/ normal RKVY Scheme.
4. Awareness activities i.e. State & District Level Kisan Mela and Block Level Kisan Gosthi are approved as per cost norms of ATMA.
5. Misc. Expenses / Monitoring & Evaluation Expenses are approved as per cost norms of NFSM.
