

Sir/Madam,

This has reference to letters No. 448-Nab./9M(Inpt.)-02/14 dated 3<sup>rd</sup> May, 2016 of Joint Secretary, West Bengal & No. 183/CC dated 13<sup>th</sup> May, 2016 of OSD & Ex-Officio Director of Agriculture & Mission Director, NFSM, West Bengal forwarding therewith the Action Plan of NFSM-CC for the year 2016-17, for an amount of Rs. 658.49 lakhs. I am directed to convey the approval of competent authority for implementation of NFSM-CC in the State of West Bengal with total outlay of Rs. **558.349 lakhs** for the year 2016-17, to be shared between Government of India (GOI) and State Government on 60:40 basis with **Rs. 319.9995 lakh as Central share** and **Rs. 238.3495 lakh as State share**. The intervention-wise physical targets and financial outlays as approved by GOI under NFSM-CC is indicated in the enclosed **Annexure-I**.

2. The State shall implement the Action Plan as per norms of NFSM-CC guidelines. The State will submit Quarterly Progress Report of Physical and Financial achievements to this Ministry on regular basis in hard and soft copies in the formats given in the guidelines of the scheme.


