This has reference to letters No. Crop/Cotton/F.No./602/2015 & Crop/NFSM/Sugarcane-revised ap/fa-2/G229-32/2015 dated 13th January, 2016 & 23rd December, 2015 respectively of Director of Agriculture, Gujarat forwarding therewith the proposal for revision of Action Plan of NFSM-CC for the year 2015-16, for an amount of Rs. 152.49 lakhs on account of revision in the sharing funding pattern between Centre & State from 50:50 to 60:40 basis.

The proposal of the State Government has been examined & I am directed to convey the approval of competent authority for implementation of NFSM-CC in the State of Gujarat with revised total outlay of Rs. **152.36 lakh** for the year 2015-16, to be shared between Government of India (GOI) and State Government on 60:40 basis with **Rs. 91.416 lakh as Central share** and **Rs. 60.944 lakh as State share**. The intervention-wise physical targets and financial outlays as approved by GOI under NFSM-CC is indicated in the enclosed **Annexure-I**.
