I am directed to refer to your letter No. Agri/Extn/NFSM-AAP/2012-13/6 dated 22.5.2013 forwarding therewith Revised Action Plan of NFSM-Rice, NFSM-Pulses and A3P and to convey the approval of Competent Authority for implementation of NFSM-Rice, NFSM-Pulses and A3P in **Assam State** with an outlay of **Rs. 5355.65 lakhs, Rs. 2468.032 lakhs and Rs. 1006.40 lakhs** respectively during 2013-14. The intervention-wise physical targets and financial outlays as approved by Government of India under NFSM is indicated in Columns (7) & (8) of the enclosed Statements and crop-wise and season-wise physical and financial targets under A3P is enclosed in Annexure.

An amount of **Rs.109.20 lakhs** under NFSM-Rice and **Rs. 42.08 lakhs** under NFSM-Pulses have been allocated to State for taking activities under Local Initiatives. It may, however, be ensured that the activities proposed under local initiatives should be part of SREP drawn by ATMA of the districts and duly approved by SFMS-EC.
