
I am directed to refer to your e-mail dated 4.5.2013 forwarding therewith Action Plan of NFSM-Rice, NFSM-Pulses and A3P respectively and to convey the approval of Competent Authority for implementation of NFSM-Rice, NFSM-Pulses and A3P in **Chhattisgarh State** with an outlay of **Rs. 4100.07 lakhs, Rs. 2391.49 lakhs and Rs.1500.00 lakhs** respectively during 2013-14. The intervention-wise physical targets and financial outlays as approved by Government of India under NFSM is indicated in Columns (7) & (8) of the enclosed Statements and crop-wise and season-wise physical and financial targets under A3P is enclosed in Annexure.

An amount of **Rs. 127.20 lakhs** under NFSM-Rice has been allocated to State for taking activities under Local Initiatives.
