Subject: **Implementation of Centrally Sponsored Scheme on "National Food Security Mission" (NFSM) during 2013-14 - Approval of Action Plan of NFSM-Rice, NFSM-Wheat, NFSM-Pulses and A3P-** regarding.

Sir,

I am directed to refer to discussions held in the Chamber of Joint Secretary (Crops) on 16.05.2013 for finalization of Annual Action Plan of NFSM for the year 2013-14 and to convey the approval of Competent Authority for implementation of NFSM-Rice, NFSM-Wheat, NFSM-Pulses and A3P in **Madhya Pradesh State** with an outlay of **Rs. 1366.23 lakhs, Rs. 6505.92 lakhs, Rs.12200.00 lakhs and Rs. 5904.40 lakhs** respectively during 2013-14. The intervention-wise physical targets and financial outlays as approved by Government of India under NFSM is indicated in Columns (7) & (8) of the enclosed Statements and crop-wise and season-wise physical and financial targets under A3P is enclosed in Annexure.

An amount of **Rs. 180.00 lakhs** under NFSM-Rice and **Rs. 120.00 lakhs** under NFSM-Wheat has been allocated to State under Local Initiative. **Under Local Initiatives the focus should be on water harvesting structures for promotion of SRI and providing irrigation under NFSM-Rice and water harvesting structures for water storages under NFSM-Wheat.** State Government is, therefore, requested to submit activity wise break up of physical targets and outlays for the amount allocated under Local Initiatives by Government of India. It may, however, be ensured that the activities proposed under local initiatives should be part of SREP drawn by ATMA of the districts and duly approved by SFSM-EC.

You are requested to implement the Scheme vigorously in the State and submit Monthly Progress Report of physical and financial achievements to this Ministry by 10th of the following month on regular basis.
