Sir,


I am directed to refer to your letter No. 8 (D)Ag/WUC/NFSM/A.P./13-14/3543-44 dated 12.8.2013 forwarding therewith Component-wise and Intervention-wise Revised Action Plan of NFSM-Wheat, NFSM-Pulses and A3P for the year 2013-14 for the unspent balance under NFSM and to convey the approval of Competent Authority for implementation of **Revised Action Plan** under NFSM-Wheat, NFSM-Pulses and A3P **in Rajasthan State** with an outlay of **Rs. 36.182 crores, Rs. 108.644 crores and Rs. 31.888 crores** respectively during 2013-14. The intervention-wise physical targets and financial outlays as approved by Government of India under NFSM is indicated in Columns (7) & (8) of the enclosed Statement and crop-wise and season-wise physical and financial targets under A3P is enclosed in Annexure.

It is further informed that the Special Plan to achieve 19+ million tonnes of Pulses production programme was approved during Kharif 2012. The said programme is not sanctioned for the current year. You are therefore, requested to utilize Unspent Balance under Special plan to achieve 19+ million tonnes <sup>by</sup> proposing additional Action Plan of equivalent amount under NFSM-Pulses.

You are requested to implement the Scheme vigorously in the State and make concerted efforts to utilize the amount fully provided under the programme. You are also requested to submit monthly progress report of physical and financial achievements to this Ministry **by 10<sup>th</sup> of the following month** on regular basis.
