
Sir,

In continuation of this Department's letter No. CPS 2-1/2015-/NFSM dated 9th April, 2015 and reference to letter No. Comm/Extn-2/NFSM/AAp15-16/FN-31/98/14 dated 29/04/2015 forwarding therewith the Action Plan of NFSM for the year 2015-16, for an amount of **Rs. 24,599.355 lakhs**, I am directed to convey the approval of competent authority for implementation of NFSM in the State of Maharashtra with total outlay of **Rs. 24,461.934 lakh** for the year 2015-16, shared between Government of India and State Government at in 50:50 ratio with **Rs. 12,230.967 lakh** as central share and **Rs. 12,230.967 lakhs** as State Share. Thus the total outlay for the State of Maharashtra comes to **Rs. 24,461.934 lakh** comprising to **Rs. 3026.096 lakh** under NFSM Rice, **Rs. 475.521 lakh** under NFSM-Wheat, **Rs. 18443.315 lakh** under NFSM-Pulses and **Rs. 2517.002** under NFSM-Coarse Cereals respectively during 2015-16. The intervention-wise physical targets and financial outlays as approved by Govt. of India under NFSM is indicated in the enclosed **Annexure-I to IV**.

2. The State shall implement the Action Plan as per norms of NFSM guidelines. The varieties of seeds of Wheat, Pulses and Coarse Cereals used shall not be more than 10 years old. State may also submit Quarterly Progress Report of Physical and Financial achievements to this Ministry on regular basis.
