In continuation of this Department's letter No. CPS 2-1/2015-/NFSM dated 9<sup>th</sup> April, 2015 and reference to your letter No. B.13012/1/2012-13-DTE (AGR-NFSM) dated 11<sup>th</sup> May, 2015 forwarding therewith the Action Plan of NFSM for the year 2015-16, for an amount of Rs. 613.00 lakhs, I am directed to convey the approval of competent authority for implementation of NFSM in the State of Mizoram with total outlay of **Rs. 613.00 lakh** for the year 2015-16, shared between Government of India and State Government at in 50:50 ratio with Rs. 306.5 lakh as central share and Rs. 306.5 lakhs as State Share. Thus the total outlay for the State of Mizoram comes to **Rs. 613.00 lakh** comprising to **Rs. 267.00 lakh** under NFSM-Rice, **Rs. 186.00 lakh** under NFSM-Pulses and **Rs. 160.00 lakh** under NFSM-Coarse Cereals respectively during 2015-16. The intervention-wise physical targets and financial outlays as approved by GoI under NFSM is indicated in the enclosed **Annexure-I to III**.

2. The State shall implement the Action Plan as per norms of NFSM guidelines. The varieties of seeds of Rice, Pulses and Coarse Cereals used shall not be more than 10 years old. State may also submit Quarterly Progress Report of Physical and Financial achievements to this Ministry on regular basis.
