
Sir,

In continuation of this Department's letter No. CPS 2-1/2015-/NFSM dated 9th April, 2015 and reference to your letters No. NFSM/06/2015 dated 07.05.2015 & 15.05.2015 and forwarding therewith the Action Plan of NFSM for the year 2015-16, for an amount of **Rs. 8795.32 lakh**, I am directed to convey the approval of competent authority for implementation of NFSM in the State of Telangana with total outlay of **Rs. 8639.551 lakh** for the year 2015-16, shared between Government of India and State Government at in 50:50 ratio with **Rs. 4319.7755 lakh** as central share and **Rs. 4319.7755 lakhs** as State Share. Thus the total outlay for the State of Telangana comes to **Rs. 8639.551 lakh** comprising to **Rs. 3398.530 lakh** under NFSM-Rice, **Rs. 4495.434 lakh** under NFSM-Pulses and **Rs. 745.587 lakh** under NFSM-Coarse Cereals respectively during 2015-16. The intervention-wise physical targets and financial outlays as approved by GoI under NFSM is indicated in the enclosed **Annexure-I to III**.

2. The State shall implement the Action Plan as per norms of NFSM guidelines. The varieties of seeds of Rice, Wheat, Pulses and Coarse Cereals used shall not be more than 10 years old. State may also submit Quarterly Progress Report of Physical and Financial achievements to this Ministry on regular basis.
