Subject: Implementation of Centrally Sponsored Scheme on "National Food Security Mission (NFSM)" - **Revised Action Plan of NFSM-Rice for the year 2015-16 on 60:40 sharing basis -reg.**

Kindly refer to letter No.TA(1)7814/15 dated 01/03/2016 from Director of Agriculture, Kerala sending therewith the revised action plan of NFSM-Rice for the year 2015-16 on account of revision in the sharing funding pattern between central and State from 50:50 to 60:40 sharing basis.

The proposal of the State Government has been examined and I am directed to convey the approval of revised Action Plan of NFSM-Rice with an outlay of **Rs. 249.990 lakh** (Central share Rs.149.994 lakh and State share Rs. 99.996 lakh).


The statement showing the intervention-wise physical targets and financial outlays as approved by GoI earlier (50:50 basis), revised proposed physical targets & outlays proposed by State on 60:40 basis and revised physical targets & outlays approved now by GOI on 60:40 sharing basis under NFSM is enclosed at **Annexure-I**.

Since State has not submitted revised proposal for NFSM- Coarse cereals, the implementation of this programme will remain on 50 :50 sharing basis between central and State Government.

Now, the total allocation under NFSM for Rice and Coarse Cereals is Rs. 253.990 lakh comprising of Rs. 149.994 lakh central share and Rs. 99.996 lakh State share under Rice and Rs. 2.000 lakh central share and Rs 2.000 lakh State share under Coarse Cereals.

The State shall implement the Action Plan as per norms of NFSN guidelines. State may also submit Progress Report of Physical and Financial achievements to this Ministry on regular basis for each programme separately.
