Subject: Implementation of Centrally Sponsored Scheme on "National Food Security Mission (NFSM)" Approval for Action Plan of NFSM for the year 2016-17 - reg.

Sir,

In continuation of this Department's letter No. CPS 2-1/2016-NFSM dated 23rd March, 2016 and reference to State Government's e-mail dated 25.05.2016 to the undersigned forwarding therewith the Action Plan of NFSM for the year 2016-17, for an amount of Rs. 9920.00 lakh. I am directed to convey the approval of competent authority for implementation of NFSM in the State of Bihar with total outlay of **Rs. 9919.981** lakh for the year 2016-17, shared between Government of India and State Government at in 60:40 sharing basis with **Rs. 5951.989** lakh as central share and **Rs. 3967.992** lakhs as State Share. Thus the total outlay for the State of Bihar comes to **Rs. 9919.981** lakh comprising to **Rs. 3965.000 lakh** (Rs. 2379.000 lakh centre share : Rs. 1586.000 lakh State share) under NFSM Rice, **Rs. 1531.000 lakh** (Rs. 918.600 lakh centre share : Rs. 612.400 lakh State share) under NFSM-Wheat, **Rs.3656.981 lakh** (Rs.2194.189 lakh centre share : Rs. 1462.792 lakh State share) under NFSM-Pulses and **Rs. 767.000 lakh** (Rs. 460.200 lakh central share : Rs. 306.800 lakh State share) under NFSM-Coarse Cereals, respectively during 2016-17. The intervention-wise physical targets and financial outlays as approved by Govt. of India under NFSM is indicated in the enclosed Annexure-I to IV.


The State shall implement the Action Plan as per norms of NFSM guidelines. The varieties of seeds of Rice, Wheat and Coarse Cereals used shall not be more than 10 years old. However, for cluster demonstrations and seed distribution in Pulses, varieties up to 15 years old are permissible. The varieties of Pulses not older than 10 years are allowed for production of quality seeds. Further, State has to ensure that at least 30 % of seed of stress tolerant Rice varieties are used under demonstrations and seed distribution.

State should conduct at least 30 % demonstrations under cropping system based approach under Rice, Wheat and Pulses component of NFSM. States also promote planting of Arhar on Rice bund under demonstration of Rice.

State may submit progress report of Physical and Financial achievement of this Ministry on Quarterly basis separately for each of the component of NFSM.
