The accounts of the grantee agency/institute/organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the institution/organization is called upon to do so. **The implementing agency is also requested to use invariably the Expenditure, Advance and Transfer (EAT) module of Public Financial Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR, 2017.**

As per Rule 238 of GFR, 2017, 'Utilization Certificate is not required in cases where Grants-in-Aid is released on the bases of duly audited accounts as reimbursement of expenditure already incurred. In these cases Sanction Order has to clearly state that UC is not required'. Further, it is directed by PFMS O/o Controller General of Accounts that the implementing agencies has to file their expenditure details in EAT module of PFMS even if the release by the Ministry is made on the basis of reimbursement of expenditure. The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure shall not to be treated as regular. The State/Agency would be forced to refund the amount received, as the expenditure that is not appearing in EAT module data shall not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction order.
